# **Council pitches in towards Little League field back taxes**

In a 7-0 vote, Hoopeston City Council approved a request from Hoopeston Little League to help pay back taxes on its field.

The ball fields, part of the former Vermilion Iron property, was purchased at auction by Brian Swinford, for \$600 and \$40 in fees. He allowed the Little League to continue to play there but his year requested the group pay \$6,800 in taxes unpaid for the last couple years.

Little League raised about \$3,800 of the money, leaving \$3,000, of which Swinford agreed to pay half. League president Glenn Brewer was at Tuesday's meeting to ask for money to pay the remaining \$1,500.

"The whole situation is a little ridiculous, in my point of view, said Ald. Alex Houmes, parks committee chairman, suggesting the money come from the parks budget.

Brewer said Little League has about \$10,000 on hand, but that new uniforms "could cost us \$10,000," He told the council that while Little League has declined in recent years, this year, there is a renewed interest in voungsters wanting to play ball.

After the meeting, Brewer said he will take what Little League raised and the city's portion directly to Danville to pay on the taxes.

Going forward, taxes on the property will drop to about \$567 per year, Brewer said. Little League has agreed to pay the taxes as part of a yearly lease, he added.

In other action, the council unanimously approved the 2016-17 budget, with income of \$2.7 million which, minus expenses and accruals, leaves a surplus of \$65.

A five-hour budget meeting on April 20 ended without a balance budget but with Goodwine continuing to look for ways to cut the few thousands of dollars over income.

After Tuesday's council meeting, Goodwine said those savings came from using actual population numbers in figuring per-capita funding in the city's share of income tax and personal property replacement tax.

At the budget meeting, Goodwine said he used 5,000 as the city's population, which is actually 5,217. Funding based on those additional residents was enough to put the budget in the black.

In unrelated business, the council:
