**City, county officials to meet Wednesday on 911 concerns**

Representatives of Hoopeston and Vermilion County Emergency Telephone System Board (ETSB) were expected to meet Wednesday to iron out concerns about guidelines and timing for Hoopeston's termination as a 911 answering point.

Ald. Brandon Hamilton made the announcement at Tuesday's Hoopeston City Council meeting, noting that the cutover date, originally scheduled for August 15, will be moved to a date after the National Sweetcorn Festival to avoid problems.

In other business, a couple from the 700 block of East Lincoln made a second plea for the city to condemn a neighbor's home.

Jimmy and Vickie Means originally requested condemnation and demolition on the home, which had been occupied by an elderly woman described as a hoarder, at the June 21 council meeting. After hearing nothing since that meeting, the couple again asked the city to do something.

The woman was taken from the home earlier this year and has been in a nursing home. "Her condition was horrific, to say the least," said Vicki Means.

Since then, the woman's son started cleaning out the home and making plans to move into it, she said.

When the resident was removed, the home had rotting food, mold and feces inside, Mrs. Means said. The son has opened windows and doors, exposing the smell and toxins of those substances to the neighborhood. "Shame on you," she told the council, "if you let someone else move into that home."

Ald. Bill Goodwine, who represents that area, said he talked to the son and was inside the home on Sunday. "I'll admit it didn't smell like fresh-cut flowers," he said, "but after 60 seconds, it wasn't noticeable."

Jimmy Means responded that EMTs on the scene when the woman was removed said the house was unin-

habitable. He said he has mowed the woman's yard for the past eight years and that the son had not been there in five years.

Mayor Bill Crusinberry said a letter from Fire Chief Joel Bird was sent, barring anyone from living in the home and that officials will find out who actually owns it.

If the woman owns it, the son may be able to rehabilitate it but he will be required to hire a licensed inspector to provide proof that the home is in good living condition.
