**Incumbent county board rep, new county candidates win**

Local wins were not as YUGE as the presidential election, but Tuesday good to area Republicans.

In the District 1 race for Vermilion County Board, incumbent Darren Duncan (R-Rossville) defeated Democrat challenger and retired Hoopeston attorney Paul Manion, 2,002 to 1,182 in unofficial results.

In District 2, incumbents Republicans Charles Mockbee III and Kevin Green kept their seats, defeating Democrat Timothy M. Rollins.

In the race for county auditor, seven-term incumbent Democrat Linda Lucas-Anstey lost her bid for reelection to Republican challenger Bill Wright, of rural Danville, who received 17,770 votes to Lucan-Anstey's 11,609.

Lucas-Anstey did carry Danville, with 5,202 votes compared to Wright's 4,663.

In the race for coroner, two newcomers were pitted against each other after incumbent Peggy Johnson did not seek reelection.

Westville Republican Jane McFadden, a Danville police commander, defeated Democrat and Tilton police chief Steve Cornett, 17,565 to 12,268.

Rounding out GOP wins, newly-elected state's attorney Jacqueline Lacy and incumbents circuit clerk Dennis Gardner and recorder Dave Stone ran unopposed and the party strengthened its majority on the county board by one seat.

In Iroquois County races, Republicans also prevailed, with Charles R. Alt and Marvin Stichnoth each winning a seat to represent District 3 on the Iroquois County Board..

Alt was the top vote-getting with 1,847, followed by Stichnoth with 1,605. Rounding out the field were Democrat Dustin Wells with 1,030 and Independent Charles Hartke with 745.

In District 1, Republicans Chad Alan McGinnis and Michael McTaggart, with 2,034 and 1,827, respectively, defeated Democrat Macklin D. Berry, with 587 votes.

In state races, Republican Mark Kirk was one and done, losing his U.S. Senate seat to Democrat Tammy Duckworth, 2,648,363 to 1,941,510.

In Vermilion County, voters outside of Danville favored Kirk, 66.17 percent to 27.42 percent. Libertarian Kenton McMillen received 4.15 percent of the county vote and Green Party candidate Scott Summers got 2.18 percent.

While statewide, Democrat comptroller candidate Susana Mendoza defeated Republican Leslie Geissler -
