Demolition crew leaves common wall intact after razing neighbor

Action to remove the building at 107 E. Main without damaging a common wall with 109 appears to have been successful.

Glynn Demolition, of Hennepin, took down the building at 107 E. Main, after the Hoopeston City Council approved the work at its November 7 meeting.

Unlike the demolition of 105 E. Main, which was done

by machinery, much of the work on 107 was done by hand to keep intact a common wall with neighboring 109 E. Main, home to Corn Town Auctions.

At the November 7 council meeting, Dustin and Russell Tarter, who opened Corn Town Auctions in February 2016, expressed concern about the demolition.

Wall continued from other side

In an email response to questions, Dustin Tarter said that as of Sunday, he had not done a full assessment of the wall, but expected to have to do some work to improve the aesthetics of it.

To keep the integrity of the wall, upper floor joists in 109 that connected with the common wall were left visible from the outside. Items affixed to the interior on the 107 side of the common wall, including outlets, shelving, and hooks - one with a jacket hanging from it - were left in place, also visible from outside.

"We appreciated the communication we've received from elected officials and the quick responses we have received after our inquiries," Tarter said.
