# HA, mental health center to apply for kids' mental health grant

Hoopeston Area schools is partnering with Iroquois Mental Health Center in Watseka on a proposal grant to the Illinois Children's Healthcare Foundation (ICHF).

Last year, ICHF launched Children's Mental Health Initiative 2.0, Building Systems of Care, Community by Community, and has earmarked \$10 million to fund \$200,000 year-long planning grants in four communities. Communities successfully completing the planning process will be eligible for six-year implementation grants of \$2.1 million each.

Proposals are to focus on building or enhancing the community's children's mental health system of care. During the year-long planning, successful communities will develop a program strategy, coordinated governance and sustainable financial model. Goals should be preventing, identifying and treating children's mental health problems, including primary care and public school partners, according to the ICHF website.

Sophomore Lucas Hofer led the team with 14 points, followed by junior Graham Eighner, with 12. Completing scoring for the team's 50-35 win were Logan Walder with nine, Ryan Drayer seven, and Brayden Bouse and Josh Delfino four each.

The Cornjerkers were 6 of 16 from three-point land. Eighner was four of seven while Walder and Draver each nabbed one.

Leading BH/RA scoring were Wyatt Edwards and Hunter Keith, with nine and eight, respectively.
