City finance committee learns of progress in development

Hoopeston City Council's finance committee met October 8 with Vickie Haugen and Logan Cronk of Vermilion Advantage to get updated information on planned economic development for the city.

Mayor Bill Crusinberry related some of the history of the planned projects, including a truck stop on the former Dick Jones property at Rtes. 1 and 9, a motel/ restaurant on land between Hoopeston Chrysler and Hoopeston Marathon; and a new First Farmers Bank and Trust facility currently under construction on Rt. 1, south of FFBT's existing building.

Crusinberry related when aldermen heard a proposal from Harry Brockus, requesting \$3 million from the city for the development projects. "A lot of the council was put off by that," he said.

Much of the \$3 million requested was for Heritage Park, site of the planned hotel and restaurant. Since then, Hoopeston Retirement Village Foundation has stepped forward and are ready to assume some of the risk. Crusinberry said.

Negotiations are ongoing for the truck stop project, Haugen said. One problem has been an issue of relocating an existing business on property earmarked for the truck stop, but officials continue to work on a solution, she said.

Using estimates from similar construction in other communities, Crusinberry presented estimates of what property taxes might be with the improvements and how the increase might be split with project developers through Hoopeston's TIF program.

Ald. Bill Goodwine, finance committee chairman and overseer of the city's tax increment financing program, said planned development will create "some jobs, not a lot of jobs," and that school representatives he's talked to "want jobs. Jobs bring in responsible people."

As the largest taxing body, the city's TIF program affects it more than others, like Grant Township and Vermilion County. "Ask yourself if this is a good expenditure from the school's standpoint, from the county's," he said.

Haugen said the perception that there are no jobs in Vermilion County is a myth. "A lot of jobs are going unfilled month after month," she said.

Crusinberry also said the city needs to pass a motel tax, which will increase revenue to the city but will not place an additional burden on taxpayers.

Currently, Vermilion County has a motel tax. If the city failed to enact one, the county would be able to collect the tax from Hoopeston's planned hotel. By passing a motel tax, Hoopeston will be able to keep those dollars, Crusinberry said.
