Hoopeston Ward 2, 4 have contests; school board field grows

Hoopeston City Council will have at least one new alderman after the April election based on filings Friday. Jeff Wise filed Friday to run for the seat being vacated by Ald. Ryan Anderson. Kellie Ferrell, also a Ward 2 resident, filed Tuesday to run for the same seat.

Another contest is shaping up in Ward 4, where incumbent Brandon Hamilton, who filed for reelection, is being challenged by Robin Lawson, who filed Friday.

In filings for Hoopeston Area School Board, a new name was added to the contest Thursday. Connie Catron filed to run for one of two seats open in the Congressional township, which houses the original Hoopeston School District.

Those filing previously include incumbent Chris Small, Lee Cox and Dave McFadden.
