Hoopeston gets wind, water, lightning damage from back-to-back storms Sunday afternoon

In what some on social media called "goose-drowners," back-to-back severe thunderstorms caused damage around the area Sunday afternoon.

The National Weather Service issued special weather statements for a strong storm in the area at 1 p.m. and a second at 2:08 p.m. Between the two, rain totals in Hoopeston varied on either side of three inches of rain. High winds shook feeble branches from trees around Hoopeston, while lightning hit others.

An emotional Paul Kelnhofer surveyed a section of missing foundation wall pushed into the basement of a house he owns at 112 E. Lincoln. "I don't know what I'm going to do," he said.

His daughter, Julie, who formerly lived in the house, pointed to a window just above the damage. "My kids used to sleep there," she said.

Kelnhofer, who has complained to the city council and the Illinois Environmental Protection Agency about problems caused by Silver Brothers' concrete runoff, is blaming the company for recent changes it made in handling runoff, claiming they changed the flow of water so more comes on his property.

Across town, Chad and Amy Coffey cleaned the mess caused by high winds on their patio. As he tried to open a patio umbrella, only to see it had been broken by the wind, she picked up debris that had blown in

Living at Third St. and McCracken, the couple is no stranger to flooding. Like Kelnhofer's house, the Coffey home is in a low area. The intersection on each end of their block of McCracken was barricaded to keep motorists from driving through the water.

Having lived in their house for years, they've seen many floods and heard from many city councils how the problem would be fixed, none of which have worked. Still, they admit in the last couple of years, the problem has improved somewhat.

Power outages caused by lightning strikes affected residents, businesses and the city both immediately

and into Monday.

Hoopeston water employees worked Monday morning to repair problems to the swimming pool monitoring system caused by power failures. Pool opening was not expected to be delayed by the problem.
