A Hoopeston man was charged with two counts of child exploitation after he allegedly exposed himself to a child under age 13.

Javier Aguirre, 34, was arrested at 4:50 p.m. Thursday in the 700 block of South First Ave., on a preliminary charge of predatory criminal sexual assault of a child. The arrest stemmed from a complaint from a 38-year-old Hoopeston woman who alleged the incident occurred at 7:32 p.m. January 29 in the 500 block of West Elm.

Aguirre pleaded not guilty Friday in Vermilion County Circuit Court. Bond was set at \$40,000/10 percent.
