# Mayor looks for volunteers to help with upcoming events that will showcase Hoopeston

Mayor Bill Crusinberry hopes some local residents will step up and help the city prepare for coming events that will shine a spotlight on Hoopeston.

The first event is the June 26 airing of the WCIA series Our Town, which will focus on Hoopeston. The series highlights communities in the Channel 3 coverage area and airs live Friday evenings during the summer.

## Medicine drop box at city hall to be discontinued immediately

Residents who wish to dispose of outdated prescriptions or those no longer needed will not be able to dispose of them at the drop box at city hall.

The box has been discontinued due to people disposing of hypodermic needles in the box.

A statement issued Monday said the "police department will no longer put personnel at risk with the non -responsible action of people who are dumping needles in the drug box."

Needles may be disposed of at Carle Hoopeston Regional Health Center.
