### New COVID case added; IDPH to offer free testing in county

Vermilion County has its 88th confirmed case of the novel coronavirus. Public Health Administrator Doug Toole announced Tuesday that a person in his 20s was confirmed to have the disease.

There have been 7,640 negative test results and two COVID-related deaths.

Toole also announced that Illinois Department of Public Health will provide free drive-through/walk-up COVID-19 testing next week in Vermilion County.

Testing is free and no appointment is necessary. Anyone, with or without symptoms, can be tested.

In Hoopeston, the IDPH mobile testing van will be at Hoopeston Area High School, 615 E. Orange, from 9 a.m.-5 p.m. Friday, July 24.

Other sites in the county, all of which will be open from 9 a.m.-5 p.m., include:
