Social Security Administration announces the start of online video hearings this fall

The Social Security Administration announced a new service for people awaiting a hearing decision. In addition to telephone hearings, Social Security will offer the opportunity for an online video hearing using the Microsoft Teams platform beginning this fall. This new free service will allow applicants and their representatives to participate in the hearing from anywhere they have access to a camera-enabled smartphone, tablet, or computer. This stable and secure online platform allows the Social Security judge to see and interact with applicants and their representatives just like an in-person hearing, while maintaining privacy of the claimant's information. Other hearing experts, such as medical or vocational experts, may participate as well.

"The COVID-19 pandemic has highlighted the importance of finding new ways to serve the public," said Commissioner of Social Security Andrew Saul. To continue to ensure all participants' safety, we expect online video hearings and telephone hearings will be the only two hearing options for the foreseeable future."

Social Security has been conducting appeal hearings with Administrative Law Judges (ALJ) via telephone

only since March, while offices remain closed to the public to protect the health and safety of the public and employees. The agency's ALJs have held more than 180,000 telephone hearings since March, allowing the agency to continue to deliver critical customer service.

For the new online video hearings, whether the device is a laptop, smartphone, or tablet on either iPhone or Android, people will experience a clear picture and audio of the ALJ and their representative during their hearing.

Editor's note: the following letter details an experience a reader had with online fraud. He wrote the letter hoping others might read it and not make the same mistakes he did. Warning - Warning - Warning

I would like to share an experience that happened recently. I received a voice mail about a charge I had with Amazon. The message said they were technical support with Amazon and that I had a charge with Amazon of \$998 for an iPhone. They were wondering if I ordered the iPhone before they charged it to me and sent it out. It so happens I just placed an order with Amazon that morning. The message gave me a number to call to verify with a four number code to give them about the order.

Of course, I called to check the situation out to see how this happened. When they answered, they said they were Amazon technical support and asked me for the code. They told me I charged \$998 for an iPhone. They asked me if I had made the charge. I told them no. Then they told me I needed to put a security code on my Amazon account and I told them I would do that later.

They then asked me which credit card I would have used to charge it. I have three credit cards for Amazon because of a business. I still didn't suspect anything about it. Then they asked what the last four digits were on the credit card I would have used. Of course, I told them. They said they didn't see the charge to that card. They asked what that card number was. I never gave it thought at that time, and gave them the number. They said that wasn't the number used for the purchase and then asked if

I could have charged it to my bank card. I told them that I don't have a bank card on file with Amazon.

It was then that I got suspicious. I told them they were not Amazon. They argued and said they were and they wanted to take the charge off for the phone. I hung up and checked my Discover card on the computer and found out I already had charges for two \$100 gift cards from Best Buy. Then the "Amazon technical support" called me back and said they did not remove the charges from my account yet. I told them they were not Amazon and not to call any more.

I called Discover immediately to cancel my card. I told a Discover representative what happened. The representative said they would turn it in to the fraud department. The Discover employee also said they had a charge for \$500 for a Wal-Mart gift card and were calling me about this charge. I said it was not my charge. They canceled that charge.

Also, a Discover representative said I already had a \$100 charge from Amazon. I told that employee that it was not mine. They said they would turn this into the fraud department also.

I contacted Amazon to let them know what happened. Amazon said they had a request for a \$100 gift card. I told Amazon what had happened and they told me they did not send out the gift card yet and they canceled the order. I called Discover back and told them Amazon took the charge off. Discover card said it would be taken off.

I thought this would be the end of this since I called Discover and reported it to the fraud department. That was not true. I just got a call from the Discover card fraud department and they told me they were not taking the \$200 off from Best Buy. I asked them why. They said since I

gave out my credit card number, it was not fraud. I did not agree and I lost. They said it was fraud to me, not to them because I gave out my card number. This just cost me \$200. Discover said to call law enforcement and report it. Discover also told me this was not the only call they

have received about Amazon calls. I called the number back from the Amazon voice mail call number I got earlier and it was an invalid number.

Lesson learned: you never can be too careful. I was fortunate I only lost \$200.
