Rise in Covid cases results in cancellation of events, movies

Organizers have pulled the plug on two upcoming special events due to increases in positive COVID-19 tests in the area.

The vendor fair sponsored by 112 Wine and Coffee Shoppe, will not be held Saturday, as scheduled. Organizer Emily Brown said the decision was made after talking to county health officials.

"Our county is experiencing a high positivity rate and large events are discouraged," she posted on 112 social media. "We have been so looking forward to this event and are heartbroken to cancel it, but we want to do our part to stop the spread and keep our community safe." She plans to hold the event next year.

Another event, Spooktacular, set for October 26, is also canceled. Sponsored by Hoopeston Jaycees, the annual event is a pre-Halloween staple, allowing youngsters to trick-or-treat at Hoopeston merchants.

When this year's Spooktacular was announced, the Jaycees requested businesses hand out individually-wrapped candy and the annual costume contest was canceled. Now, the entire event is a no-go. The social media posting for the change said, "we were informed by the City of Hoopeston that the Spooktacular would have to be cancelled."

Trick-or-treating on Halloween has not been canceled, and youngsters may go door-to-door from 5:30 -7 p.m. on Halloween night. Participants are asked to follow COVID-19 guidelines regarding social distancing and face coverings.

In a final closing, Save the Lorraine officials have announced no movies will be shown at the Little Lorraine until further notice.

Public Health Administrator Doug Toole on Tuesday announced that Vermilion County had 17 new positive tests. Five of the new cases are family-related to previously reported positive cases. The additions brings the county total of positives to 1,112. Of those, 224 cases are active, with 10 hospitalized. Forty-three people were released/recovered Tuesday.

In Wednesday morning numbers posted by Illinois Department of Public Health, a cumulative total of 65 positive cases was reported in the 60942 zip code, which includes Hoopeston and Cheneyville. That is up from 58 on Sunday. Other communities and total positive cases include:
