Filing closes for April consolidated election; contests to be had for city, school board seats

Hoopeston Area School Board and Hoopeston City Council will see significant changes in the wake of the April 6, 2021 election.

At the city level, Ward 4 is losing longtime Ald. Bill Goodwine, who has represented the ward since he was appointed October 1, 1991 to replace Dennis Catron.

Two men filed to represent the ward: Chris Small, a

former Hoopeston Area School Board member and Robert Porth, making his first foray into elected office.

In Ward III, Joe Garrett and Jeff Keith each filed to replace former alderman Alex Houmes, who resigned earlier this year.

Ald. Lourdine Florek is running unopposed for the four-year term in the ward.

In Ward II, incumbent Carl Ankenbrand, who was appointed in 2002, is being challenged by Kellie Ferrell for the four-year term. This is Ferrell's second try for the seat.

In Ward I, incumbent Bill McElhaney, appointed to the council in 2008, will face Kyle Richards for a four-year term.

Ward 1 also has a two-year term caused when former alderman Chad Yaden resigned. No one filed for that seat.

Bill Crusinberry, running for his fourth term as mayor, is being challenged by Mike Bane, who previously served as the city compliance officer under Crusinberry.

Both mayoral candidates filed at the same time on the first day of filing. A lottery to determine ballot placement will be held at 8:30 a.m. Tuesday at Hoopeston City Hall.

Three incumbent Hoopeston Area School Board members did not file for reelection in the April 6, 2021 election.

City Clerk Gail Lane and Treasurer Edye Bookwalter are running unopposed.

Lawrence Jahn, who joined the board in 2005, Lisa Leigh, who first ran in 2009, and first term member Craig Lee did not file by Monday's deadline, according to information provided by the Vermilion County Clerk's office.

Incumbent Debbie Klaber, first elected in 2017, did file, along with Sharon Zorns, Elizabeth Silver, Cheryl Steiner and Travis Field.

Klaber, Zorns and Silver are running for two seats representing inside the congressional township in which the district is located.

Klaber holds one of those seats and Jahn held another. Leigh, of East Lynn, and Lee, of Wellington, repre-

Leigh, of East Lynn, and Lee, of Wellington, represent the part of the district outside the congressional township. Steiner, of East Lynn, and Field, of Wellington, are running for those seats.
