

## **Hoopeston Public Library opens to public Monday**




Director Tricia Freeland asks that masks be worn inside the building at all times for the safety of patrons and staff. Public access computers and reading areas will be open for 30 minute use with masks and social distancing required.

Hand sanitizer is available at all entrances and exits and patrons are asked to utilize this service when entering and exiting the building.

Seating areas, computers, hand rails, door handles and restrooms will be disinfected daily. All returned materials will be under a 3-day quaran-

No in-person programs or meeting space will be available. The children's room is open but play areas will remain closed. Curbside pickup and drop-off of materials will still be available for those patrons who prefer this option.

Mayor Bill Crusinberry ticked off a list of topics, new and old, at a quick Hoopeston City Council meeting Tuesday night.

Casey's General Store was expected to close on four properties on Rtes. 1 and 9 needed for the new, larger Casey's, he said. Structures on the properties will be demolished. Construction is not expected to begin until spring, he said.

In related business, Crusinberry pointed out contradicting ordinances concerning building fees. An older ordinance sets the fee at "like \$50 for a \$100,000 building." Under the more recent ordinance, the fee would be more like \$2,500, he said.

The mayor also said Downtown Motel owner Sabah Yokhana has indicated he will ask for a variance in order to enclose entrances at the motel. The request will be heard by the Hoopeston Plan Commission, which will make a recommendation to the city council.

Crusinberry said the city was notified that Region 6 of Gov. J.B. Pritzker's 11-region Covid map went from Tier 3 to Tier 1. Due to the change, Crusinberry said he thinks the council can return to in-person meetings, effective for the February 2 session.

According to the Illinois Municipal League handbook, officials can still attend electronically but to conduct business, a quorum of alderman must be present at the meeting site.

No decision was made whether to continue the electronic meetings to the public can participate. Few citizens have joined the remote meetings since they began being offered.

Since March, council attendance has been a mix of remote and in-person participation.

In other business, the council approved, 5-0, a Certificate of Substantial Completion for the water/sewer extension from the west side of Rt. 1 to the east side, for the new Casey's. Ald. Carl Ankenbrand was absent.
