# With more questions than answers, council declines to approve resolution without information

Hoopeston officials are no closer to approving a cooperation agreement between the city and Vermilion Housing Authority (VHA) than they were in November.

Mayor Bill Crusinberry raised the issue for discussion at Tuesday evening's council meeting, saying the U.S. Department of Housing and Urban Development (HUD) is pushing for action on a resolution affirming a previous cooperation agreement that reads like it was written in the 1950s.

A new resolution is required because when the former Vermilion County Housing Authority (VCHA) board resigned in 2018, property and documents went to VHA, a new entity combining VCHA and Danville Housing Authority.

The most recent VHA resolution includes wording about funding for 112 new units for low-income housing but Crusinberry has previously stated he believes that language was in a document that predated Parkview Court. built in 1951.

Ald. Bill Goodwine had several questions about the agreement. "I'm not a big fan of HUD and more subsidized housing," he said. The document has no expiration date and nothing to prohibit construction of more lowincome housing. Hoopeston's population has decreased and there are already many empty houses in the city.

Also, he said, no property taxes are paid on government -owned low-income housing, but the city must provide its

services, including police protection, water/sewer service and streets.

VHA has submitted a request to tear down the existing Parkview Court and replace it with town homes and duplexes. Goodwine wondered what would happen to current residents while the project was underway.

Crusinberry answered that when a Rossville housing project was updated, two tenants were moved while those units were improved. Residents where shuffled around from there until the project was done. "I'm sure they have a plan," he said. "I don't think they're going to put people out on the street."

A proposed resolution drafted by city attorney Dave Wesner would affirm the concept but contains a clause stating, "the re-execution of the Cooperation Agreement is not intended to allow or provide for the building and maintenance of any additional low-rent housing projects." However, Goodwine said that resolution is to affirm the original agreement, which allows for new construction.

Ald. Jeff Wise agreed. "I feel if we're signing off on this, we're sighing off on 112 units," he said. "We've got so many 'I don't knows' in here."

"It's pretty wide open," Goodwine agreed.

Ald. Carl Ankenbrand wondered if new construction would have to get council approval, but Goodwine, who called the original document "kind of a convoluted agreement," said it "goes on and on about we have to cooperate, but nowhere does it say we have to approve it."

Ald. Lourdine Florek suggested officials need to consider how much low-income housing Hoopeston needs. She said 2019 data showed 22.1 percent of Hoopeston residents live below the poverty line. The state average is 11.5 percent, and neighboring communities have lower rates, as well, with Watseka at 14.2, Gibson City at 16.4, and Paxton at 11.3. Also, preliminary estimates of Hoopeston's population from the 2020 census puts the number of residents at around 4,830, which will increase the percent of those living under the poverty level.

"When I first came here, (the city council) got rid of

trailer parks because they were unsightly and didn't attract people who kept up their property, who weren't good citizens," she said. "At what point to we say 'that's enough,' or is there a point when we do say, "ok, that's enough. We need to think about that."

Wise asked if the council will have any say in Parkview Court plans and commented on the per-unit cost of the \$10 million estimated project cost, with \$6.6 million estimated for construction. Crusinberry cited prevailing wage and other factors.

He will also try to find answers to aldermen's questions about the agreement. In other business:

• Crusinberry announced sealed bids for perpetual care are being accepted until 9 a.m. Friday, March 26. Bids will be opened at 10 a.m. on that day. Specs, available at city hall, call for live plants this year. "The perpetual care fund does not maintain itself," he said. This will save the city some money."

• He added there is still time to submit a sealed bid on an Exmark mower used by the cemetery department. Specs are available at city hall or on the city's website, www.cityofhoopeston.com. Minimum bid is \$1,500, due by 9 a.m. March 12. Bids will be opened at 10 a.m. that day.

• Crusinberry explained why he has not assigned the newest aldermen to committees, saying with the election so close, he did not want to put Steve Eyrich and Joe Garrett as committee chairmen when that might change after the election. "That's why I let it ride," he said. "We'll see how the election works out, not only for me but for the council seats, then we'll figure out what committees everybody's going to be on."

• Aldermen approved, 7-0, a 2019-20 Motor Fuel Tax maintenance expense statement. Ald. Bill McElhaney was absent.

Ald. Robin Lawson announced Hoopeston Fire Depart-

Nonplussed, Crusinberry related the information. "We'll get on that," Silver said.
