## Mayor updates council on property, Dollar General, Casey's

Mayor Bill Crusinberry updated aldermen on several matters during Tuesday's Hoopeston City Council meet-

Attending remotely, Crusinberry announced:

• An application has been submitted to the tax trustees to purchase 105 E. Main for \$800. The transaction should be finalized in 60 days.

The purchase price is small compared to what officials have already spent on the property, which was purchased by William Thomas in 2017 at a tax trustee sale. He planned to open an electronics store at the location.

In October, the roof on the building collapsed and the city waived bids and approved a proposal to demolish it

#### lar General's engi-Ferrell proposes abandoned property registry

Ald. Kellie Ferrell, Civic Committee chairman, is proposing that vacant properties in Hoopeston be placed on a registry at their owners' expense.

At Tuesday's Hoopeston City Council meeting, Ferrell presented a proposed vacant buildings ordinance for council consideration. Vacant buildings are defined as those that meet one or more criteria, including being: unoccupied and unsecured; unoccupied and secured by other than normal means; unoccupied and an unsafe building, as determined by the enforcement officer; unoccupied and an enforcement officer has issued an order to correct code violations; occupied but does not possess a properly registered, operating business or non-profit with a valid certificate of occupancy, as required within the fire limits; or is illegally occupied.

Under the proposed ordinance, owners of such buildings have 30 days to register after the building becomes vacant. Owners of residential vacant buildings will be a registration fee of \$100 for a building less than 5,000 sq. ft. or \$500 for large buildings. Fees for non-residential buildings will be \$500 for any building smaller than 5,000 sq. ft., and \$750 for a larger building. Building owners would be required to maintain enough insurance to repair or demolish the building. Owners of buildings that will remain vacant will be assess an annual registration fee of \$500 until the property is demolished or rehabilitated. Owners who fail to pay the registration fee, due January 1 of each year, will be charged a \$100 per month

The council is expected to vote on the ordinance at its September 2. meeting.

Based on the EPA's ruling, Silver Bros. submitted a new bid for a price not to exceed \$50,000. The original bid was for \$13,890.

In other business, Ald. Jeff Wise announced tree work has begun, with 18 trees taken down in the week before Tuesday's meeting. A tree service is doing the cutting, which will last two to three more weeks, Wise said. Street and Alley workers are cleaning up debris after trees are felled. No stump grinding will be done now.

With tree cutting at the forefront, other chores will be delayed or canceled, including fall alley cleanup. "I know a lot of people won't be very happy about it," Wise said.

In other unrelated business, the council:

- Heard from Ald. Lourdine Florek that a pump at the water plant broke and will be fixed when parts arrive. Because the plant has to be shut down for the repair, ground storage tanks will be filled to provide water while repairs are made. Water Supt. Steve Baker said the work will be done during the night. when water use is lowest.
- Unanimously approved the appropriations ordinance, which is

the city's budget plus a five percent across-the-board contingency.

- Heard from Ald. Stephen Eyrich who said the full time opening at the cemetery has been filled. Justin Rice has been on the job about a week and "is doing a great job,"
- Several committee meetings were called, including:
