

Shut tight

The former Countryside Mall, 217 E. Main, is barricaded after it was condemned, vacated of squatters and secured. Photos of the building, including the interior, were presented in Hoopeston Municipal Court Wednesday. Owner Mihail S. Mihalios was ordered to demolish the building immediately, said Ald. Kellie Ferrell, Hoopeston Civic Improvement Committee chairman. After court, city employees were called to secure the building with lumber and chains. Because 221 and 223 E. Main are connected, although they were not condemned, Mihalios is denied entry is barred from accessing them until 217 has been removed. Ferrell hopes the building is gone before Mihalios' next court date. If not, she said she will seek city council approval to use tax increment financing funds to demolish it, then place a lien on the property to recoup the cost.


