Watseka man plans new NAPA store, asks city for help; fireworks show 'up in the air': Wise

A Watseka man is asking for assistance from Hoopeston in relocating a downtown business.

NAPA owner Roger Dittrich told Hoopeston City Council Tuesday evening that he plans to open a new 6,000 sq. ft. NAPA store on property south of Heritage Health on Rt. 1.

"I haven't had very much luck here in Hoopeston," Dittrich told the council, saying he was in Hoopeston four years ago about relocating his store to the former Essex building, which did not happen.

Four years later, Dittrich plans to purchase land from Hoopeston Retirement Village Foundation. "I'm here to see what the city can do for me," he said, detailing the benefits his new store will provide. The \$400,000 store will create additional property taxes and a minimum 30 percent increase in sales, bringing in more tax dollars to Hoopeston.

"I'm here to ask what I can do to get the permits, water and sewer taps, all those things that need to be done," he continued. "I'd like to break ground when the weather breaks, unless I hit another road block, which, as I said, I haven't had much luck in Hoopeston."

Mayor Jeff Wise said he has been working with the attorney to subdivide and plat the property. He asked whether the city has water to the site.

Ald. Lourdine Florek, city water chairman, said Hoopeston ran new lines to the site when the new Heritage Health was built, so a ready water supply is available.


Wise said he and HRVF president Dave McFadden are working to get the legalities in order and the project move ahead. "As far as getting you started, It's just a question of knocking on the attorneys," which both men are trying to do.

"I hope I get a little better treatment here than I have in the past," Dittrich said, adding, "I haven't had good luck in the past. I'm not looking for a free ride."

In other business, fireworks were discussed in two separate ways.

During the public comment part of the meeting, Lee Cox, owner of Cox Memorials, addressed the council about selling fireworks from his business. Cox has been in contact with the State Fire Marshal's office and Fire Chief Joel Bird, who said he has no objections. Cox said he thought about selling fireworks from his rural Hoopeston home, which would mean Vermilion County would get the sales tax. However, he decided against that, preferring to sell them at his business, with Hoopeston getting the sales tax.

Later in the meeting, Wise said "fireworks for this year

in Hoopeston is up in the air."

Wise and McFadden discussed whether Hoopeston will have a fireworks display this year.

"There is concern about supply and cost," Wise said. "If the city wants fireworks this year, we're definitely going to have to work for it."

The company that provided Hoopeston's pyrotechnic display was bought out by a larger company, which has put Hoopeston on its schedule, Wise said, adding "the \$25,000 show is probably going to be closer to \$40,000."

The city's usual donation of \$5,000 "is five minutes of fireworks."
