Alley cleanup

Hoopeston alley cleanup is scheduled to begin April 18 weather permitting. This is for yard waste only. Piles with construction debris or other materials will not be picked up. Those without alleys may pile items at curbside but not in the street.

Hoopeston Fire Department and police responded at 9:46 p.m. Saturday to a house fire in the 500 block of West Main. Assistance was requested from Rossville, Rankin and East Lynn departments. No injuries were reported.

After the fire, Chief Joel Bird took to the department's Facebook page, saying that one car drove around the fire trucks while firefighters were getting needed tools and another vehicle drove over the supply line. He warned that at future fires, motorists who do such things will be ticketed.

"I understand this was on one of the busiest streets in town," he wrote. "Use common sense and use one of the side roads to get around. My patience in this matter is no longer."

According to tax records, the house, believed to be vacant, has switched owners three times since 2020. From

former owner Lois Cox, the property went to Guardian Tax IL LLC, an Omaha, Neb., firm, who then quit claimed it to 11T IL LLC, also based in Nebraska. Both list the same address and agent. In August 2021, the property was quit claimed, to LLC End of the Road. Information on the corporation was not immediately available.
