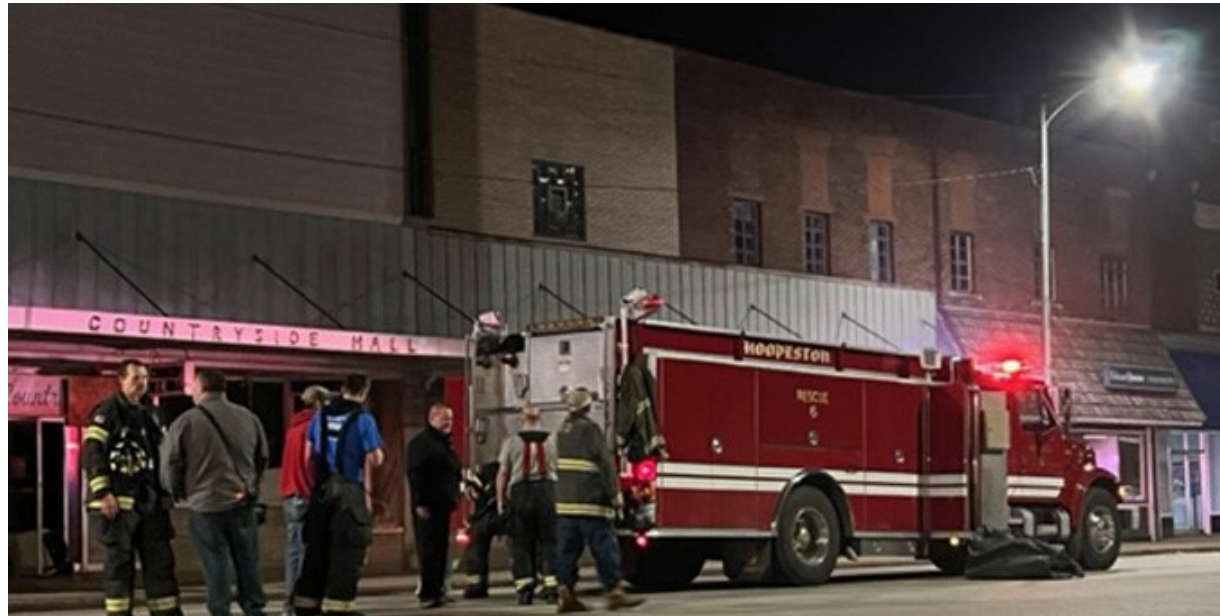

## Hoopeston man charged with arson in Countryside fire

A Hoopeston man is facing a preliminary charge of arson of real property in connection with a fire at the former Countryside Mall, 217 E. Main.

Hoopeston Fire Department was called at midnight Thursday for a fire in the unoccupied building and quickly extinguished it.

An investigation by the State Fire Marshall, the fire department and Hoopeston Police Department led to the arrest of Stephen Tyler Spivey, 33. He was charged and taken to the Public Safety Building in Danville to await arraignment.

Earlier Thursday morning, the fire department was called at 12:27 a.m. to the 600 block of East McCracken for a fire in an unoccupied house. Fire and police personnel were called back to the scene at 2:30 p.m. Saturday

when the fire rekindled. That fire is also under investigation.
