Coroner: drugs responsible for man's death

WATSEKA - Iroquois County Coroner William Cheatum on Thursday issued a statement saving the death of Apolinar Solis Jr., of Hoopeston was caused by drug

Mr. Solis, 32, was found unresponsive in a holding cell at the Iroquois County Jail on May 12, while in the process of being booked into the jail earlier that morning. He had been arrested on an outstanding Newton County, Ind., warrant.

Cheatum issued a report on preliminary autopsy findings, saying no unidentified natural diseases were present and no evidence of significant or internal trauma that caused his death, according to the release.

Upon receipt of Mr. Solis' toxicology report, the forensic pathologist ruled his cause of death as "acute toxicity of cocaine and methamphetamine due to cocaine and methamphetamine abuse."

After results of the toxicology report were released, Mr. Solis' friends and family said a second autopsy was conducted in a different facility at the family's request.

Just the Facts contacted a family member about the results of that autopsy and will report the details when they are available.

Mr. Solis' death was investigated by the Illinois State Police.
