Hoopeston native to retire as circuit judge on September 30

Circuit Court Judge Nancy Samaras Fahey, a Hoopeston native, will retire on September 30, 2022, after nearly 16 years on the bench.

Before she was elected circuit court judge in 2006, Fahey had a career as an educator and a lawyer.

After graduating from Illinois Wesleyan University in Bloomington, with a BA in education and a minor in English, she taught first grade in Cissna Park for six years and served as Cissna Park Education Association vice president.

By 1988, she had graduated from Southern Illinois University School of Law, in Carbondale, and, after passing the bar exam, was hired by Manion. Janov, Devens & Fahey, for whom she had clerked during law school.

In 1991, she was hired by the Dukes,

Martin, Helm & Ryan law firm; later becoming a partner in the firm. While there, she represented a number of local governmental entities including Danville Township, Georgetown Township and the Hous-

During her tenure as Circuit Court Judge, she has handled a variety of cases. She spent more than half of her career on the criminal felony call, presiding over more than 100 trials, including many murder trials. She is currently the senior Circuit Court Judge in the county and is currently the only female Circuit Court Judge in the Fifth Judicial Circuit.

Upon retirement, Fahey plans to spend more time with her family, travel,

and expand her footprint in local politics. Fahey is married to retired Circuit Court Judge Thomas Fahey. Between them, they have three sons, two daughters-in -law, and three grandchildren.

A reception honoring Fahev will be held at the Vermilion County Courthouse on September 30.




