Former furniture store transforming to indoor storage units, possible event center, or ???

The Stebbins Furniture building is going from being a store to being somewhere residents can store their stuff.

Hoopeston Indoor Storage, at 315 E. Main, provides a temperature-controlled, indoor location where residents can store items, including golf carts and motorcycles.

The building has been empty for a while, used only occasionally for rummage sales. Jeff Stebbins, son of building owner Shirley Stebbins, suggested to Adam Taubert that he buy the building. Taubert agreed and the men decided to transform the building.

Stebbins will run the venture, consulting with Taubert, but leave him to concentrate on his duties as pastor of

First Baptist Church of Hoopeston. "I'll still be making hospital visits and doing marriage counseling," as well as other ministerial duties, Taubert said.

Both 10' x 10' and 10' x 5' will be available, Stebbins said. Nine 10' x 10' compartments have been created in the back half of the building.

A grand opening special rate is being offered: three months at \$50 per month. The regular rate is \$90/month for the large space and \$70/month for the smaller one.

A bonus for renters is that the storage area will not get overly hot or cold. With heating and cooling, the temperature is expected to be between 50 and 55 degrees year-

round.

What is left to decide is what to do with the front portion of the building. Stebbins and Taubert are still kicking that around. Suggestions have including putting in a golf simulator or hatchet-throwing. Taubert said the area, with its high ceilings, could accommodate bounce houses for kids birthday parties. Stebbins is leaning towards making it an event center.

Hoopeston Indoor Storage is open from 8 a.m.-8 p.m. For more information or to lease a storage area, Stebbins can be reached at (217) 260.3869 or visit www.hoopestonindoorstorage.com.
