Gov. J.B. Pritzker signs law limiting semi-auto guns, mags, Bailey says 'come take them'

Illinois on Tuesday became the ninth state to place restrictions on commonly held semi-automatic fire-

Passed by the General Assembly, Gov. J.B. Pritzker signed the "Protect Illinois Communities Act" into effect Tuesday. The law bans the purchase, sale and manufacture of semi-automatic so-called "assault weapons" and large-capacity magazines

The law stops the sale of several common semiautomatic firearms by name or description of features and limits magazines to 10 rounds for rifles and 15 for pistol mags.

Residents who own the now-banned guns will have until January 1, 2024 to register them with the Illinois State Police, providing the make, model and serial number of the specified weapons to obtain a special endorsement on their Firearm Owners Identification, (FOID) card. Failure to do so could result in violators facing up to three years in prison.

"For a long time now, I and many other leaders in the Illinois General Assembly have prioritized getting the most dangerous weapons off our state's streets," Pritzker said Tuesday. "Today, honoring the commitment we made, we passed one of the strongest assault weapons bans in the nation, one I will be proud to sign.

"No Illinoisan, no matter their zip code, should have to go through life fearing their loved one could be the next in an ever-growing list of victims of mass shoot-See LAW on other side

ings. However, for too long people have lived in fear of being gunned down in schools, while worshipping, at celebrations or in their own front yards. This legislation will stop the spread of assault weapons, highcapacity magazines, and switches and make our state a safer place for all. I look forward to signing this bill immediately, so we can stop the sale of these deadly weapons as soon as possible."

Although the law was praised by Pritzker, pro-gun individuals and groups are gearing up to mount legal challenges to it, including some legislators.

Darren Bailey, (R-Xenia), who was unsuccessful in an attempt to unseat Pritzker, said after the bill passed that he would not comply, posting on Twitter, "I'll die on my front porch before anyone takes my guns away. My message to Springfield: If you want my guns, come get them."

Bailey and other Republican lawmakers said the law violates the Second Amendment. Bailey said he would fight the rule in court.

While not responding directly to Bailey, Pritzker said, "You don't get to choose which laws you comply with in the state of Illinois, let's be clear."

Lawmakers are not the only ones with whom Pritzker may have a problem. Many Illinois counties have declared themselves pro-Second Amendment counties.

In January 2022, Vermilion County approved, 19-4, an ordinance making it the 67th county to back the

Second Amendment Preservation Act. Under it, the sheriff can enforce the ordinance to keep the federal or state government from infringing upon any lawful gun owner.

To the same extent, Iroquois County passed a resolution in 2018.

Not only do pro-Second Amendment representatives say the law is illegal, they also criticize how it was moved to a vote: incorporated into an amusement ride safety bill.

Additionally, gun supporters say the law will do nothing to increase public safety, pointing to Chicago, which has stringent gun laws, but one of the highest rates of gun violence in the nation.

The Illinois State Rifle Association (ISRA) and National Rifle Association (NRA) also came out against the measure.

The new law was proposed by state Rep. Bob Morgan, (D-Deerfield) after the July 4, 2022 shooting in Highland Park, in which seven people were killed and many more injured.
