

Hoopeston officials are expected to approve a bid Tuesday night to tear down several buildings, including from the former Bubble Gum Shop on Market up Main and around, taking in the former restaurant/bar on the corner down to just east of the Doyle Law Office.

Hoopeston City Council expected to approve bid to demolish several downtown buildings

Hoopeston City Council is expected to approve a bid to demolish several downtown buildings at its meeting Tuesday night.

Properties to be demolished include 215-229 E. Main, which includes everything east of the Doyle Law Office to the corner at Market; 209-213 S. Market, which were the site of a former karate studio and clothing store; the former Chronicle building at 308 E. Main and the former

food locker at 210 E. Penn, all under one bid.

Alternate bids were also sought to demolish the former Lester Drugs at 220 E. Main, as well as to put metal siding on the exposed walls of 211 E. Main, 310 E. Main, 222 E. Main, and 218 E. Main, which share a common wall with buildings to be torn down.

Bid packets were sent to six contractors, with three submitting bids. They are:

• ARD Farms & Contracting, owned by Allen Decker of Wellington. The project base bid is \$410,000, with work completed in 60 days. ARD did not bid to finish the outer walls of adjoining buildings but did submit a bid of \$50,000 to demolish the Lester building. The bid also stipulated that concrete would be taken to ARD Farms-approved site to process, which would reduce city landfill

Demolish continued from other side

- Ken Lee Demolition, Inc., of Paxton, bid \$424,900 for the base project. Alternate bids of \$35,500, \$36,000, \$19,000 and \$15,000 were submitted to cover the exposed walls of abutting buildings and \$48,500 to demolish Lester's. A date of completion for the project would have to be determined.
- Sniders Trucking, of Danville, was the final bidder, a base bid of \$524,000 plus \$29,000, \$20,000, \$20,000, and \$20,000 for outer wall work on each building, respectively, and \$88,000 to take down 220 E. Main. Virgin backfill material could be used, if needed at \$13 per cubic yard with unified backfill for demo site, crushed brick and concrete, at \$8 per ton. Bob Brown Construction, of Hoopeston, was listed as a subcontractor on the bid form for excavation.

Funds to pay for the demolition are expected to come

from the city's tax increment financing account.

A use for the cleared land has not been announced. Other agenda items for Tuesday's meeting include:

- Acceptance of a water treatment plan bid and rejection of a bid for the Market St. water main replacement;
