# Night lights

Through the holiday season, Just the Facts will feature lighted Christmas displays around Hoopeston, starting with the biggest residential display, Thomas's Light Show on Penn St., across from McFerren Park. Chad and Robin Thomas started the show in 2013. They have expanded it each year - including to the neighboring house - and have programmed music to coordinate with the light show. Each night, 11 to 13 songs play as the lights change colors and shapes. Usually, six of the songs are on nightly, including the Linus and Lucy opening, Amazing Grace, Military Tribute, Miracle on 34th with Chad explaining the show, and Charlie Brown's "The Meaning of Christmas. The display is on 5-10:30 p.m. nightly and The Candy Shak is open weekends from 5:30 to 9:30 p.m.
