Hoopeston's Edward Jones office has temporarily moved to 1006 W. Chestnut after its downtown office was condemned.

Edward Jones temporarily relocates after condemnation

Edward Jones Financial Advisor Lance Raver and his office administrator, Traci Jones, moved. The business' temporary address is 1006 W Chestnut St., Hoopeston, located behind the former Hoopeston Express Lube in Hoopeston Plaza.

At 209 E. St. for many years, Raver had to find a new location after his building and the neighboring 211 E. Main were affected by the downtown demolition project. Raver's office has been closed since January 30.

According to county records, 211 E. Main is owned by Patricia Doyle and was the former home of her travel agency and her husband, Richard Doyle's, law practice.

At its meeting Tuesday, Hoopeston City Council approved, 5-2, condemning both addresses, which Mayor Jeff Wise said are one building.

Council members Kellie and Michael Ferrell voted against the measure. Ald. Bob Porth was absent.

Wise said owners would pay the 2023 property taxes, with the city picking up the tab for demolition, landfill fees and paying two months of 2024 taxes.

"Be aware," Wise said, that any future building will be offered the same deal.

The only other building currently affected by nearby demolition is at 310 E. Main, and is owned by Gail Lane. It is next to the former Chronicle office at 308 E. Main.

During the public comment section of the meeting, Lane was asked if she wanted to comment about the situation.

"I'd rather not say anything tonight," she answered, saying she wanted to talk to an alderman first.

Wise said he spoke to a structural engineer who said the building would have to be repaired to be safe. "It is unsafe as it stands right now," he said. "It either gets repaired or it will be condemned. There is no middle ground."

Lane seemed surprised by his comment and responded with "Oh."

Also during public comment, several residents spoke for and against the planned Invenergy Musketeer wind farm plan. Those speaking against the proposal cited the sound of "blades swishing" and that the wind turbines would limit possible Hoopeston expansion.

The council later approved, 5-2, a redrafted wind ordinance specifying the measure must be approved by the council and Vermilion County officials.

In discussion before the vote, Ald. Joe Garrett asked for clarification that the vote was just for the ordinance and not the siting agreement. Wise assured it was just for the ordinance but wondered why anyone would vote for the ordinance but not the siting agreement.

Saying Hoopeston schools look to get \$1.5 million per year from the windmills, "Let me state my peace here," Wise said. "If we want the county to approve this, we, as a city, need to approve this." When the issue goes to the county, "this \$1.5 million will be on the line," and if it
